- 2. You are advised to contact the Department of Planning, Transport and Infrastructure regarding qualifications necessary to operate a boat.
- 3. Seek professional advice if necessary in relation to the completion of this form, including taxation and legal issues.
- 4. The person who currently holds the permit must complete Part A(1) and Part B of this form, and the statutory declaration at the end of Part B.
- 5. The person to whom the permit is to be transferred must complete Part A(2) and Part C of this form, and the statutory declaration at the end of Part C.
- 6. Part D is required to be completed by all persons applying to be a registered master, including the permit holder. Refer to pages12 to 14 of this application in relation to registered masters.
- 7. All parts of the application form must be submitted at the same time. If the proposed transferee is a company, please ensure that the relevant attachments are enclosed with the application.
- 8. If there are one or more persons or entities registered on the public register as having an interest in the permit that is to be transferred, they must provide consent to the transfer. You must seek this consent and attach it to this application. If a bank is a registered interest holder, the written consent must be provided on bank letterhead and / or be stamped with the bank seal.
 - Third party interest holders should also complete the "Cancellation of 3rd party interest form" that is attached to this application.
- 9. All applications must be completed in full before being lodged with PIRSA Fisheries & Aquaculture. GENERAL INFORMATION

- 1. The Fisheries Management (Miscellaneous Developmental Fishery) Regulations 2013 provide that a developmental permit may be transferred with the consent of the Minister. An application for consent must be in writing and must be made on this
- 2. The Fisheries Management (Miscellaneous Developmental Fishery) Regulations 2013 provide that: The Minister may only consent to the transfer of a permit if satisfied as to the following:
 - (a) that any fees or other amounts payable in relation to the permit under the Act have been paid in full;
 - (b) that the permit to be transferred has not been suspended;
 - (c) that no proceedings alleging an offence against the Act or the repealed Act are pending or likely to be commenced in the State against the holder of the permit:
 - (d) if the transferee is a natural person—that the transferee is at least 15 years of age and is a fit and proper person to hold a permit in respect of the fishery;
 - (e) if the transferee is a company—that each director of the company is a fit and proper person to be a director of a company that holds a permit in respect of the fishery.
- 3. 'Catch History' is the amount of fish taken by a permit holder pursuant to a permit issued under the Fisheries Management Act 2007. In some fisheries, when management arrangements have changed, catch history has been used as one of the relevant criteria when allocating resources. It is important to note that it is NOT policy in South Australia to recognise the transfer of catch history from one permit holder to another when a permit is transferred.
- 4. Upon the death of a permit holder, the permit will become vested in the personal representative of the deceased, as part of the estate of the deceased. requirements that apply in this situation are set out in section 57 of the Fisheries Management Act 2007.
- 5. The Fisheries Management Act 2007 provides that a public register of authorities (including permits) issued under the Act must be kept. This register must include, among other things, a notation that a specified person has a registered interest in a permit. This notation will be made upon application by the holder of the relevant permit, and on payment of the prescribed fee.
- 6. If you are in the process of acquiring a permit under the Fisheries Management Act 2007 you are advised to make independent enquires of the permit holder as to any demerit points that are recorded on that permit. The Public Register may not be up to date at the time of your search as there are sometimes delays in the allocation process and so should not be relied upon in isolation from other enquiries any demerits that are incurred by the permit as at the time of the transfer will be attributed to the relevant permit in the ordinary course of business regardless of any transfers occurring in that period. If you require further clarification of the actual demerits held by a permit prior to any transfer you will need to request that from PIRSA Fisheries in writing and as part of that process you will need written consent of the permit holder for that information to be released to you.

FALSE AND MISLEADING INFORMATION

A person must not make a statement that is false or misleading in a material particular (whether by reason of the inclusion or omission of any particular) in any information provided, or record kept, under this Act.

Maximum penalty:

- (a) if the case where the offence involved the making of a false or misleading statement, or the provision of false or misleading information, relating to a quota entitlement under a fishery authority—
 - (i) if the offender is a body corporate—\$300 000;
 - (ii) if the offender is a natural person—\$60 000;
- (b) in any other case—
 - (i) if the offender is a body corporate—\$100 000;
 - (ii) if the offender is a natural person—\$20 000.
