Consultation was undertaken with HeliSurveys and consent was not provided to release the personal information of the employee of HeliSurveys.

As a mobile telephone number allows a person to be contacted outside of business hours and is information that is not ordinarily available to the public, the information is taken to concern the personal affairs of an individual.

Accordingly, it is considered that disclosure of this information would be an unreasonable intrusion into the privacy rights of the individual concerned with an expectation that their personal information would not be released in this way.

Hi Lisa,

Thanks for the opportunity to respond to this request.

Heli Surveys would like to object documents 1 and 2 being released under the following parts of the Act:

- Clauses 7(1)(a) and 7(1)(b)
- Clauses 4(1)(a) and 4(2)(a)(i)

We believe that the disclosure of these documents to the public would damage our competitive ability when competing for work of a similar nature, are commercial in confidence and are a trade secret. The video clearly shows our equipment, set up and configuration. These have been developed over years and totaling costs of many hundreds of thousands of dollars. For other commercial operators to be provided with high quality video of these would several affect our ability to be competitive in future tenders and request for quotes. In addition to the video, the audio shows our "patter", communication protocol and SOP's for the operation, again a trade secret developed over years.

The videos also have accurate GPS locations stamped into the videos which would allow for anyone to know the locations where feral deer could be, resulting in illegal hunters endangering the life or physical safety of members of the community

In summary, we agree with your determination to not release the documents originally and object to them being released now.

The Department of Primary Industries and Regions (PIRSA) processed an application made under the <u>Freedom of Information Act 1991</u> (the Act) from the Hon Heidi Girolamo MLC seeking video captured by aerial culling teams on 25/3/2023.

#### **Background Information:**

The documents (video footage) in scope of the application (as described below), contain information concerning your business affairs.

Document No	Description of document
1	Video footage dated 25/3/2023
2	Thermal camera video footage dated 25/3/2023

PIRSA made a determination to Ms Girolamo refusing access to the documents (video footage), based on the following clauses of the Act:

- Clauses 4(1)(a) and 4(2)(a)(i) Documents affecting law enforcement and public safety, eg with respect to the locations where feral deer could occur, resulting in illegal hunters endangering the life or physical safety of members of the community
- Clauses 7(1)(a) and 7(1)(b) Documents affecting business affairs, eg trade secrets, commercial value with respect to the unique thermal imaging camera set-up provided by your business

Consultation was not undertaken with you on these documents, given that PIRSA was not considering to release this information.

### **Application for Internal Review:**

Ms Girolamo has now lodged an application for Internal Review, so PIRSA is required to review the processes undertaken with the original application. Notwithstanding that PIRSA refused access to Documents 1 and 2, as part of the review process, I am contacting you to seek your views on the potential release of these documents (video footage).

### **Action required:**

Section 27 of the Act provides that before the applicant can be given access to the documents, PIRSA must first consult with you to obtain your views as to whether or not you believe the documents are exempt, pursuant to the clauses of Schedule 1 of the Act. An 'exempt document' means a document that the agency may determine not to release to the applicant.

Accordingly, I am providing you with the opportunity to raise any objections to the release of the documents, or parts of the documents. If you object to their release, please advise on what basis you believe they would be exempt, pursuant to the clauses of Schedule 1 of the Act.

Please note that, although it is a legislative requirement that PIRSA consults with you and seeks your views, the agency must make an independent determination as to whether the documents are exempt. If you believe the documents are exempt, but this agency disagrees and determines to provide access to the applicant, you will be notified and given an opportunity to seek a review of this agency's determination.

In accordance with Premier and Cabinet Circular PC045, if the attached documents are disclosed as a result of this FOI application, details of the application, and the documents to which access is given, may be published in PIRSA's disclosure log. A copy of PC045 can be found at:
