

Fisheries Management (Miscellaneous Fisheries) Regulations 2013

For the purpose of regulation 11 relating to periodic returns – I make the following determinations –

Regulation 11(1) (Periodic return)

- (1) The holder of a licence in respect of the fishery must in respect of each calendar month during the currency of the licence complete a return form contained within the 'South Australian Commercial Marine Scalefish and Miscellaneous Fisheries Daily Catch and Effort Logbook' (return) and deliver the return to the Department, at the address specified in the form, within 15 days of the end of the month to which it relates.
- (2) If the holder of a licence takes no aquatic resources under the licence during a particular calendar month, he or she is required to furnish a return in respect of that period indicating that no such aquatic resources were taken.
- (3) If the fishery has been closed for a whole calendar month, the holder of a licence need not furnish a return for that month.
- (4) A licence holder in respect of the Miscellaneous Fishery subject to a condition fixing a Giant Crab quota entitlement in meeting the responsibilities set out in paragraph ((1)) must complete a return form contained in the "South Australia Commercial Giant Crab Log".
- (5) A licence holder in respect of the Miscellaneous Fishery subject to a condition allowing harvest of Native Oysters (*Ostrea angasi*) in meeting the responsibilities set out in paragraph ((1)) must complete a return form contained in the "South Australian Commercial Fishing Daily Log Scallops and Mud Oysters".
- (6) A licence holder in respect of the Miscellaneous Fishery subject to a condition allowing harvest in Lake Hope in meeting the responsibilities set out in paragraph ((1)) must complete a return form contained in the "South Australian Inland Waters Catch and Effort Returns".
- (7) A licence holder in respect of the Miscellaneous Fishery subject to a condition allowing harvest of Scallops (Family Pectinidae) or Sea Urchins (*Heliocidaris erythrogramma*) in meeting the responsibilities set out in paragraph ((1)) must complete a return form contained in the "South Australian Commercial Fishing Daily Log Scallops and Mud Oysters".
- (8) A licence holder in respect of the Miscellaneous Fishery subject to a condition allowing harvest of Marine algae from a point on the shore 100 meters north of the northern breakwater at Cape Jaffa Marina in meeting the responsibilities set out in paragraph ((1)) must complete a return in writing providing the following information
 - a) Date of fishing activity
 - b) Licence/permit number
 - c) Name of person recording data
 - d) Key marine algal types taken
 - e) The volume of harvested marine algae

- f) The exact location (latitude and longitude) of the harvest activity
- g) The estimated area of beach within which harvesting occurred, including the length and width of the beach (in metres)
- h) The method used to take marine algae
- i) Photographic images taken immediately prior to and immediately after each harvest activity. Images are to be taken from a point at one end of the harvested area that clearly includes all of the area of marine algae taken. Images are to be dated and gee-referenced
- j) The volume of product sold each month and the form of that product.

Regulation 11(2) (Keeping records)

(1) The holder of a licence must—

- (a) make a copy of each return form that he or she completes under this determination before the return is sent or delivered to the Department; and
- (b) retain the copy for a period of 12 months from the last day of the month to which the return relates.
