PART 4 – FEES

A boat fee will be applied to your licence as follows:

If the licence is endorsed by licence condition to use only one boat at a time, the fee applicable will be for the highest passenger survey class.

If the licence is endorsed by licence condition to use more than one boat at the same time, fees will be applicable for each of those endorsed boats.

For the 2023/2024 licensing year, these fees are:

- For a boat surveyed to carry up to 6 unberthed passengers, \$445
- For a boat surveyed to carry between 7 and 12 unberthed passengers, \$889
- For a boat surveyed to carry more than 12 unberthed passengers, \$1779

The above 2023/24 fees have been reduced by 50% to reflect the approved annual licence fee relief for this financial year.

NOTE:

- If you are removing a boat or adding a boat of the same survey class, the fee is **\$139.**
- If you are removing a boat and adding a boat of a **higher** survey class **only the difference** in the fee is payable.
- If you are **removing all boats** from your Charter Boat licence no fee is applicable.

PUBLIC LIABILITY INSURANCE INFOMATION

Regulation 7(3)(f) of the *Fisheries Management (Charter Boat Fishery) Regulations 2016* requires all Charter boat licences with a boat endorsed on it to have current public liability insurance to an amount of at least \$10,000,000.

You will be required to provide a certificate of currency whenever your policy is renewed.
