request that the Minister for Primary Industries and Regional Development, as administrator of the Langhorne Creek Wine Industry Fund (the Fund) established under the *Primary Industry Funding Schemes (Langhorne Creek Wine Industry Fund) Regulations 2016*, refund those contributions made by me to the Fund relating to the 2018 vintage and do solemnly and sincerely declare that:

### 1. Refund Sought by a Winemaker

#### a) Winemaker Contribution Paid on Other Person's Grapes
