1B LOOKING ITS BEST

BE RESPECTFUL

The 1B motif needs to breathe, and must be protected with a minimum of clear space equal to the size of the 'B' from 1B.

A minimum size of 20mm (or 90 pixels) has been set to ensure legibility and consistency.

DON'T

Low contrast background

The motif needs to be used in a consistent, legible manner. This will encourage recognition and trust in the program and its content.

Don't:

- Distort or rotate the motif
- Remove parts of the motif
- Re-colour any part of the motif
- Add unauthorised tag lines to the motif
- Use non brand colours
- Place on a low contrast background: a reverse version of the motif has been created for use where the motif is being placed over a graphic or colour that would make the motif difficult to see in its standard form. In any instance where the motif is placed over a graphic, all elements of the motif must be completely legible. If the motif is not legible in standard or reverse formats, a different background must be selected.

INFORMATION FOR DESIGNERS

One Biosecurity standard fonts and colours are available on the following pages and can be provided to designers as needed.
