INSTRUCTIONS FOR COMPLETION OF APPLICATION

- 1. A separate application form is to be completed for each proposed transfer to a different licence holder.
- 2. Transfer of Marine Scalefish quota will not alter the annual licence fees that apply. Your fees will not be recalculated. You will still be charged the full licence fee, including any outstanding instalments, for the remainder of the year. Licence holders should consider these fees when negotiating the transfer price of the quota.
- 3. All applications must be completed in full before being lodged with PIRSA Fisheries & Aquaculture. Applications that are not complete, or that do not have correct documentation attached, will be returned. Please contact PIRSA Fisheries & Aquaculture on (08) 8207 5332 if you have any queries. Both parties MUST initial each page (bottom corners) where indicated.

INFORMATION ABOUT TRANSFERS

- 1. The Regulations provide that the Marine Scalefish quota unit entitlements can only be transferred to other Marine Scalefish fishery licences or Rock Lobster Fishery licences endorsed with Marine Scalefish Access Option C.
- 2. Snapper Quota can only be transferred to Rock Lobster Fishery licences already endorsed with Permanent Snapper quota entitlements.
- 3. Quota entitlements must be transferred to 2 decimal places only.
- 4. Quota entitlements should not be fished until you have received written confirmation that the entitlements have been endorsed on the licence.
- 5. Multiple zones and species are transferrable in the one application form.
- 6. Permanent transfers and temporary transfers must be submitted on separate application forms.
