**APPLICATION TO TRANSFER
ROCK LOBSTER QUOTA UNITS AND POTS**

INSTRUCTIONS FOR COMPLETION OF APPLICATION

1. A separate application form is to be completed for each proposed transfer to a different licence holder.
2. **Transfer of rock lobster quota will not alter the annual licence fees that apply. Your fees will not be recalculated.** You will still be charged the full licence fee, including any outstanding instalments, for the remainder of the year. Licence holders should consider these fees when negotiating the transfer price of rock lobster quota.
3. **All applications must be completed in full before being lodged** with PIRSA Fisheries & Aquaculture. Applications that are not complete, or that do not have correct documentation attached, will be returned. Please contact PIRSA Fisheries Aquaculture on (08) 8207 5332 if you have any queries. Both parties **MUST** initial each page (bottom corners) where indicated.

INFORMATION ABOUT TRANSFER

1. **Where a southern zone rock lobster quota unit is transferred to another licence, a southern zone rock lobster pot entitlement must also be transferred to the same licence at the same time.**
2. The minimum pot holding is 40 pots and the minimum quota holding is 40 units. However, you may temporarily transfer below these holdings. Please note that if you make an application that results in the number of pots endorsed on your licence being reduced to less than 40 in number, the *Fisheries Management (Rock Lobster Fisheries) Regulations 2017* provide that it is an offence to take any fish pursuant to your licence. This includes any species in schedule 1 of the regulations and the taking of razor fish for bait.
3. The maximum pot holding is 100 pots.
4. **Any quota entitlements carried over** from the previous quota period must be fished on the same licence and **cannot be transferred.**
5. Quota entitlements can be transferred in **whole uncaught** units only.
6. Quota entitlements should not be fished until you have received written confirmation that the entitlements have been endorsed on the licence.
7. **Applications cannot be processed** if there are any pending trips for your licence in eCatch. All trips need to be completed to ensure quota balances are correct at time of transfer.
