INSTRUCTIONS FOR COMPLETION OF APPLICATION

1. Transfer of GSV Class A/ Class B Fishing Night units may be submitted to PIRSA Fisheries & Aquaculture on one application form.
2. **All applications must be completed in full before being lodged** with PIRSA Fisheries & Aquaculture. Both parties **MUST** initial each page (bottom corners) where indicated.

INFORMATION ABOUT TRANSFERS

1. If you want to transfer some units permanently and some units temporarily, you will need to complete two separate forms.
2. Only available units can be transferred.
3. Any **carried over nights cannot be transferred** and will not be carried over to the following season.
4. Unit entitlements should not be fished until you have received written confirmation that the entitlements have been endorsed on the licence.
