## GENERAL INFORMATION

1. The Fisheries Management (Charter Boat Fishery) Regulations 2016 provide that a licence in respect of the charter boat fishery may be transferred with the consent of the Minister. An application for consent must be in writing and must be made on this form.
2. The Fisheries Management (Charter Boat Fishery) Regulations 2016 provide that: The Minister may only consent to a transfer of a licence if satisfied as to the following:
(a) that any fees or other amounts payable in relation to the licence under the Act or the repealed Act have been paid in full;
(b) that the licence to be transferred has not been suspended;
(c) that no proceedings alleging an offence against the Act or the repealed Act are pending or likely to be commenced in the State against the holder of the licence;
(d) if the transferee is a natural person, that the transferee is at least 15 years of age and is a fit and proper person to hold a licence in respect of the fishery;
(e) if the transferee is a body corporate, that every member of the governing body of the body corporate is a fit and proper person to be a member of the governing body of a body corporate that holds a licence in respect of the fishery;
(f) if a boat is registered for use under the licence, that there is in force a policy of public liability insurance under which the transferee is insured or indemnified in an amount of at least $\$ 10000000$ in relation to death or bodily injury or property damage that may be caused by or arise out of the use of the boat under the licence.
3. Upon the death of a licence holder, the licence will become vested in the personal representative of the deceased, as part of the estate of the deceased. The requirements that apply in this situation are set out in section 57 of the Fisheries Management Act 2007.
4. The Fisheries Management Act 2007 provides that a public register of authorities (including licences) issued under the Act must be kept. This register must include, among other things, a notation that a specified person has a registered interest in a licence. This notation will be made upon application by the holder of the relevant licence, and on payment of the prescribed fee.
5. If you are in the process of acquiring a licence under the Fisheries Management Act 2007 you are advised to make independent enquires of the licence holder as to any demerit points that are recorded on that licence. The Public Register may not be up to date at the time of your search as there are sometimes delays in the allocation process and so should not be relied upon in isolation from other enquiries any demerits that are incurred by the licence as at the time of the transfer will be attributed to the relevant licence in the ordinary course of business regardless of any transfers occurring in that period. If you require further clarification of the actual demerits held by a licence prior to any transfer you will need to request that from PIRSA Fisheries \& Aquaculture in writing and as part of that process you will need written consent of the licence holder for that information to be released to you.

## FALSE AND MISLEADING INFORMATION

For the 2023/2024 licensing year, these fees are:

- For a boat surveyed to carry up to 6 unberthed passengers, \$445
- For a boat surveyed to carry between 7 and 12 unberthed passengers, \$889
- For a boat surveyed to carry more than 12 unberthed passengers, \$1779

The above 2023/24 fees have been reduced by $50 \%$ to reflect the approved annual licence fee relief for this financial year.
