## Determination under the Freedom of Information Act 1991

I refer to your application made under the *Freedom of Information Act 1991* which was transferred back to the Department of Primary Industries and Regions (PIRSA) on 16 August 2021, seeking access to the following:

"Any and all documents that list departmental wardens, livestock animal health officers, biosecurity officers or others within PIRSA who have been gazetted Inspectors under the Animal Welfare Act 1985."

Timeframe: 1/01/2019 to 1/08/2021

Following contact made with you by PIRSA's Freedom of Information team seeking clarification of your application, on 25 August 2021, it was confirmed that your request is revised as follows:

"A list of staff including departmental wardens, livestock animal health officers, biosecurity officers or others within PIRSA's Animal Health Business Unit who were/are during the period stated Inspectors under the Animal Welfare Act 1985 and employed by PIRSA between 01/01/2019 to 01/08/2021."
