- Carefully read all information contained in this renewal form and ensure all parts are complete.
- Write legibly using a blue or black pen or use a software program with a “Fill & Sign” function.
- You may be requested to provide additional supporting documentation or information beyond what is contained in this renewal form to assist in the determination of the application made.
- Applications made requiring additional documentation or information may be refused if the documentation and/or information is not provided within the specified period requested.
- An application fee invoice will be generated once the application has been received and verified by PIRSA Fisheries and Aquaculture.

IMPORTANT NOTES:

- The term of a corresponding licence is co-extensive with the term of the lease, and the licence is renewed for a further term on each renewal of the lease (without any requirement for a separate application).
- An aquaculture lease (and therefore its corresponding licence) will not be renewed unless an application is made to renew the lease prior to the expiry of the term of the lease.
- If the lease holder does not apply to renew the aquaculture lease, the lease and its corresponding aquaculture licence/s will expire.
- If an aquaculture lease and corresponding licence expire, aquaculture will no longer be permitted to be carried out under the lease and licence.
- Applications made relating to lease holders with outstanding fees owing to PIRSA may be refused.

- Whether the lessee is in breach of, or has previously breached, a condition of the lease.
- The extent to which the lessee has complied with the obligations, conditions and standards of compliance imposed on a lessee under the *Aquaculture Act 2001*, the *Aquaculture Regulations 2016* and an aquaculture policy applying in respect of the lease.
- Whether a corresponding licence holder is in breach of, or has previously breached, a condition of a corresponding licence.
- The extent to which a corresponding licence holder has complied with the obligations, conditions and standards of compliance imposed on a licensee under the *Aquaculture Act 2001*, the *Aquaculture Regulations 2016* and an aquaculture policy applying in respect of the licence.
- Whether a corresponding licence holder has contravened a notice issued under section 33 of the *Livestock Act 1997*.

This includes, but is not limited to, annual reporting provisions, payment of fee provisions, translocation approval, and adequacy of any applicable bank guarantee, indemnity scheme, and public liability insurance.

These requirements apply to each person and/or company who holds the aquaculture lease.
