NOTICE TO FISHERS - SOUTHERN ZONE ABALONE FISHERY

TACC AND MANAGEMENT ARRANGEMENTS FOR 2021/22

I write in relation to the Total Allowable Commercial Catch (TACC) for the Southern Zone Abalone Fishery (SZAF) 2021/22 quota period.

Total Allowable Commercial Catch (TACC)

In setting the TACC for the 2021/22 quota period, I have considered the following;

- The objects of the Fisheries Management Act 2007:
- The outcomes of the draft harvest strategy contained in the draft *Management Plan for the South Australian Commercial Abalone Fisheries (2021)*, currently being considered for adoption by the Minister for Primary Industries and Regional Development;
- The year-to-date scientific information provided by SARDI for the SZAF from the 2020/21 quota period; and
- Advice from the Southern Zone Abalone Management Inc on recommended management arrangements for the 2021/22 quota period.

As delegate for the Minister for Primary Industries and Regional Development, I have made the following determination for the SZAF 2021/22 quota period commencing 1 October 2021 under the *Fisheries Management (Abalone Fisheries) Regulations* 2017:

- the number of kilograms of abalone meat that is to be the value of an abalone unit and the conversion value for Blacklip Abalone of the SZAF at 36.663 kg meat weight and 0.3333, respectively, for the 2021/22 quota period. These values correspond to a TACC of 132,000 kg whole weight.
- the number of kilograms of abalone meat that is to be the value of an abalone unit and the conversion value for Greenlip Abalone of the SZAF at 9.999 kg meat weight and 0.3333, respectively, for the 2021/22 quota period. These values correspond to a TACC of 1,800 kg whole weight.

Fishing Areas, Catch Caps and Size Limits

In addition, the following catch caps (whole weight) and minimum legal lengths for Blacklip Abalone will be implemented for the 2021/22 quota period to allow for the fine scale spatial management of the Southern Zone Abalone Fishery. Note that changes to Fishery Areas (FAs) for the 2021/22 quota season have been highlighted in grey below and are consistent with the recommendations made by the Southern Zone Abalone Management Inc.

In response to a request from the Independent Chair of the Southern Zone Abalone Management Inc, the Hon Rory McEwan, the Minister for Primary Industries and Regional Development has requested the Department of Primary Industries and Regions (PIRSA) seek the necessary legislative amendments to the boundaries of FA in the SZAF to enable the creation of a new FA in the area of Middle Point (FA11) to be implemented by the beginning of the 2021/22 fishing season on 1 October 2021.

The boundaries of each FA are described in the *Fisheries Management (Abalone Fishery) Regulations 2017*. Therefore, implementation of a new FA and changing the boundaries of the Middle Point FA will require amendments to this legislation. PIRSA is currently seeking the necessary legislative amendments to implement these arrangements.

Further information will be provided to all licence holders in the SZAF prior to the beginning of the 2021/22 quota period on 1 October 2021 advising catch caps and minimum legal size for the proposed new FA.

Undersized fish in the Southern Zone Abalone Fishery

TAKE notice that for the purposes of clause 5(2)(a) of part 2 of schedule 2 of the *Fisheries Management (General) Regulations 2017* I hereby revoke all prior notices published in the South Australian Gazette declaring undersized lengths of Blacklip Abalone in the Southern Zone Abalone Fishery and hereby declare that Blacklip Abalone (*Haliotis rubra*) taken in an abalone fishing area of the Southern Zone Abalone Fishery is undersized if its length is less than that specified below:
