## NOTICE TO PROCESSORS

Information on electronic reporting for the Northern Zone Rock Lobster Fishery, Southern Zone Rock Lobster Fishery and Miscellaneous Fishery for fish processors accepting consignment of Giant Crab.

Dear Registration holder

I write to provide an update on the implementation of electronic reporting for Giant Crab in the Northern Zone Rock Lobster, Southern Zone Rock Lobster and Miscellaneous fisheries.

An electronic catch reporting system has been developed that has enabled fishers to report their catch for Giant Crab quota. This will improve the integrity and reliability of the quota arrangements in the fishery and result in a more effective and efficient management of the Northern Zone Rock Lobster, Southern Zone Rock Lobster and Miscellaneous fisheries.

Fishers will now be nominating the processor they are consigning their catch to electronically.

Processors will be able to view all consignments for Giant Crab by accessing eCatch through the myPIRSA portal.

Particulars about reporting have been detailed within the 'Giant Crab Fishery – Electronic Reporting Reference Guide' which will be provided to all fish processors. This user guide will explain how to create a myPIRSA account and apply for and use the eCatch service.

Fishers will commence submitting Giant Crab CDRs electronically from **3 October 2023**. During the transition fishers and fish processors will temporarily be required to dual report their catch until advised to the contrary. Dual reporting requires fishers and processors to report their catch using a paper-based Catch and Disposal Record (CDR) as well as the new electronic CDR (eCDR). This will mean that Processors will also need to dual report consignments received until the licence holders have fully transitioned to eCDR reporting only.

New Ministerial Determinations have been put in place to support the new reporting arrangements for the purposes of regulation 12 of the *Fisheries Management (Fish Processors) Regulations* 2017. You will need to familiarise yourself with them.
