The South Australian horticulture/viticulture industry is of huge importance to South Australia, both economically and socially. The Riverland region of South Australia is considered one of Australia's major production areas, especially for the production of almonds, stone fruits, citrus and wine grapes.

The South Australian Horticultural Industry Blueprint suggests that a growth could continue to be achieved through R&D to drive productivity and improve efficiencies, investment and adoption of new technology and capturing export growth opportunities. If this growth trend was achieved over the next 5 years, it would be possible to see more than 3,000 additional new full-time jobs created plus more than \$330 million in additional farmgate value delivered to SA.

Feedback from industry in the Riverland is that they want their business underpinned by modern technologies and associated research, and desire to be forefront adopters of new technology. Businesses therefore want to gain access to new technology, with the technologies trialled and calibrated to suit their regional conditions.


