Invitation to Information Sessions - Draft Harvest Strategy Framework for the Marine Scalefish Fishery

Dear Licence holder,

As part of work to develop a replacement *Management Plan for the South Australian Commercial Marine Scalefish Fishery*, a new draft Harvest Strategy Framework (HSF) has been prepared by the Department of Primary Industries and Regions (PIRSA) with input from the South Australian Research and Development Institute (SARDI) and guidance from the Marine Scalefish Fishery Management Advisory Committee (MSFMAC).

Commercial and recreational fishing sector representative organisations have been invited to provide comment on the draft Harvest Strategy Framework by 29 February 2024.

To support stakeholders to consider and feed in comments on the draft HSF, information sessions have been organised at key locations across the state.

The information sessions will be provided by PIRSA and SARDI staff and will provide further details on the proposed draft HSF and will go through example applications. Please see the draft HSF enclosed with worked examples.
