Determination under the *Freedom of Information Act 1991*

I refer to your application made under the *Freedom of Information Act 1991* which was received by the Department of Primary Industries and Regions (PIRSA) on 15 May 2026, seeking access to the following:

"A table of the number of each enforcement order (including but not limited to Section 9 orders, Section 43 orders, warrants, and any other enforcement orders) issued by PIRSA each month, by postcode, between 1 January 2025 and 30 April 2026."

Upon receipt of your application, PIRSA's Records Management and FOI Support Officer contacted your office seeking clarification of "enforcement orders" and the timeframe, as your application referred to 1 January 2026 in the "from" section.

On 15 May 2026, it was confirmed that the orders are those made under the *Plant Health Act 2009* and the timeframe commences from 1 January 2025.

On 18 May 2026, further clarification was sought from your office and it was confirmed that the orders are in relation to fruit fly. Accordingly, your application was amended as follows:

"A table of the number of each enforcement order made under the Plant Health Act 2009 (including but not limited to Section 9 orders, Section 43 orders, warrants, and any other enforcement orders) issued by PIRSA each month, by postcode, in relation to Fruit Fly, between 1 January 2025 and 30 April 2026."

Accordingly, the following determination has been finalised.
