You must submit an application to PIRSA Fisheries and Aquaculture to obtain the written approval of the Minister prior to any translocation event outlined under the *Prohibition of Entry into and Movement within South Australia of Aquaculture Stock* Notice 2020. Allow 5 working days for the application to be processed. If the translocation request has no precedent and is considered high risk, you may be notified that the assessment process will be greater than 5 days to allow for risk assessment and consultation.

Note that in some circumstances, health certification of incoming stock by an accredited laboratory will be required and animals must be translocated within a certain period of time from the date of health testing. If in doubt, contact PIRSA Fisheries and Aquaculture (details above) to minimise delays in obtaining stock.

Unauthorised translocations may result in a breach of the *Livestock Act 1997* which could result in fines of up to \$20,000 or licence cancellation.
