Internal Review Determination under the Freedom of Information Act 1991

I refer to your application for Internal Review made under the *Freedom of Information Act* 1991 received on 11 November 2021.

Your original application, sought access to the following:

"Copies of all credit card statements for credit cards held by all current and former staff members in the current Minister's Office, and for the Minister's Office including Office Managers and Executive Assistants but excluding any credit cards that have been proactively disclosed. Copies of all documents and records including but not limited to financial statements, bank statements, credit cards statements, briefings, minutes, correspondence, reports, emails, receipts, letters and written notes of reimbursements paid to the Minister, former Minister and all former or current staff in the Minister's office." From 26/03/2018 to 31/08/2021

It is noted that you have proceeded to Internal Review as the Office of the Minister for Primary Industries and Regional Development failed to determine your original application within the legislative timeframe, and therefore deemed a refusal of access.

Internal review of the documents

Following an independent internal review of your application, I advise the following:

Issues in this review

The Office of the Minister for Primary Industries and Regional Development did not provide a determination within the legislative timeframe, pursuant to the Freedom of Information Act.

Alternatively, you can apply to the South Australian Civil and Administrative Tribunal (SACAT). If you wish to seek a review, you must do so within 30 calendar days of receiving this internal review determination.
