Determination under the Freedom of Information Act 1991

I refer to your application made under the *Freedom of Information Act 1991* which was received by the Department of Primary Industries and Regions (PIRSA) on 3 August 2020, seeking access to the following:

"All communications between the Office of the Minister for Primary Industries and Regions and the Department for Primary Industries and Regions covering former Minister Tim Whetstone's July 2018 study tour trip to the United States. We seek documents that include:

- Emails exchanged between agencies
- Itinerary documents
- Documents that detail travel arrangements (including accommodation)"

On 19 August 2020, contact was made with you by PIRSA's Freedom of Information and Privacy Officer seeking clarification of your application. Your application was on hold for a period of fourteen days in the course of negotiations on the scope. It was confirmed that you are seeking all documents, including requests for briefings and background information. Accordingly, the date in which to make a determination in response to your application was amended to 16 September 2020.

The following determination has been finalised.

I have located forty-four documents that are captured within the scope of your request.

"6 - Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)."

The information removed consists of:

- names and telephone numbers of third parties; and
- · matters of private concern to an individual.

Accordingly, it is considered that disclosure of this information would be an unreasonable intrusion into the privacy rights of the individuals concerned.

Determination 3

I have determined that access to the following document is granted in part:

The information removed from the above document is pursuant to Clause 7(1)(c) of Schedule 1 of the Freedom of Information Act which states:

"7 - Documents affecting business affairs

- (1) A document is an exempt document -
 - (c) if it contains matter -
 - (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
 - (ii) the disclosure of which -
 - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
 - (B) would, on balance, be contrary to the public interest"

In addressing the public interest test requirement for this exemption, I have balanced the following factors:

In favour of the public interest:

- Meeting the objects of the Act favouring access to documents.
- Ensuring optimal use of public resources.
- High level of interest in the accountability of public office holders.

• The importance of transparency and openness and the interest that the public has in the decision-making processes of Government.

Contrary to the public interest:

- Disclosure of this information would reveal detail which is considered commercially sensitive to the company concerned.
- It is expected that release of this information would result in a competitive disadvantage to the company concerned and potentially jeopardise future business planning between the company and Government.
- If third parties cannot be assured of confidentiality by Government with respect to communications relating to their commercially sensitive information, this would have the potential to harm business relationships with Government and hamper future dealings with agencies for the betterment of South Australia.
- Disclosure of this information would be expected to prejudice the future supply of information to Government, as the level of trust in handling such information would be substantially diminished.

Having considered the various factors weighing for and against disclosure, I have determined that disclosure of this information would, on balance, be contrary to the public interest.
